# **ACTIVITY – THE CENTRE**

- administers exams based on which national standards of students' academic achievement are evaluated (State Matura exams, national exams and other external evaluation exams)
- takes part in international assessments in education (PISA, TIMSS, TALIS, ICCS...)
- builds item banks
- analyzes, statistically processes and publishes the results of administered exams
- produces and publishes exam catalogues and handbooks for preparation and administering exams
- based on evaluation analyses, gives suggestions to the Ministry of Science and Education for

permanent improvement of the quality of education

 conducts external evaluation of experimental programs

 prepares models for external evaluation of educational institutions, licensing and certifying vocational qualifications

 organizes seminars for external collaborators (authors of exam items, scorers, boards for particular subjects etc.) about exam preparation, production and administration

- conducts and takes part in scientific research in the area of educational measurement and external evaluation of knowledge, skills and other competences
- performs other tasks regarding administering State Matura, national exams and other external evaluation exams.

The Centre is responsible for comprehensive external evaluation of the pre-tertiary education system in the Republic of Croatia.



### PROJECTS PROPOSED FOR FUNDING FROM THE EUROPEAN SOCIAL FUND

#### EXTERNAL EVALUATION OF EDUCATIONAL INSTITUTIONS

Systemic and continual external evaluation of educational institutions ensures valid, objective and reliable information on the quality of work of individual educational institutions. The comprehensive approach to external evaluation of educational institutions encompasses key areas of work in schools and specific subjects within those areas to be evaluated, as well as specific questions that schools need to answer with valid arguments. The model is conceptually related to schools' self-evaluation, and together they form a complementary model whose implementation in the system contributes to raising responsibility, improving schools' work and achieving better results.

#### DEVELOPING THE SYSTEM OF NATIONAL ASSESSMENT

One of important components in establishing a comprehensive system for monitoring the quality of education is the item bank, in which exam items of good metrical characteristics from different subjects are stored, which teachers could use in their work. An important part of that system are national exams, whose goal is to determine students' achievement in key knowledge in key parts of educational cycles.

#### **CERTIFICATION OF VOCATIONAL QUALIFICATIONS**

Through certification of vocational qualifications, a national system of professional-theoretic and practical final exams would be established for external evaluation of students' or candidates' competences according to the criteria prescribed in the standard of profession and Croatian Qualifications Framework's standard of qualification for individual vocational qualifications. The quality of vocational education and competitiveness of specific qualifications on the labour market would increase, strengthening at the same time the vocational education system in the Republic of Croatia.

#### PRINCIPAL LICENSING

Principal licensing is a procedure during which a candidate would prove in what way they have achieved the level of training necessary for successful school management in accordance with standards of their profession. The professionalization of principals in education requires the transformation of their role from position holders to professionals.
